Catalog Description: A study of the structure and history of the English language. (May be repeated once for credit when topic varies.)

Course Description: A course in cognitive linguistics primarily concerned with the role metaphor plays in structuring human thought and communication.

Course Learning Outcomes

- Students will demonstrate understanding of metaphor and its role in language and thought.
- Students will demonstrate understanding of poetic metaphor.
- Students will demonstrate understanding of the role of metaphor in academic disciplines, such as literary criticism, philosophy, education, advertising, and art.
- Students will demonstrate understanding of the relationship between metaphor, the body, and meaning-making—otherwise known as embodied cognition.
- Students will demonstrate clear and concise writing.

Course Assignments

- Daily reading response blog posts composed on course site. See minimum requirements below.
- Handmade responses accompanying blog posts.
- Question at Issue related to the role metaphor plays in human thought and communication. Two sentences in blog post:
 - The Question at Issue
 - Why it is a relevant question for you and others
- Annotated Bibliography of 6 peer-reviewed sources related to question at issue and posted in blog
 - 200 word annotation minimum
- Abstract of proposed article or conference proposal posted in blog
 - 500 word minimum
- Class presentation on Question at Issue and Abstract with one handmade visual illustrating some aspect of question, thesis, or argument

Minimum Requirements for Daily Reading Response Blog Posts

Students will post on their course blogs daily reading responses. These posts will be 3 short paragraphs of at least 200 words in which they briefly summarize the argument of the assigned or selected reading. Students will (1) identify what they take to be the main claim of the assignment, (2) summarize the evidence or examples cited to support the main claim, and (3) convey a question that arose out of their reading followed by a potential answer to that question. In addition, students must give each blog entry an original title and at least 3 category tags – (1) the author's last name or the authors' last names, (2) name of the reading assignment, (3) and a topic they believe fits the blog entry. Students must fulfill all of these requirements to receive credit for their blog posts.

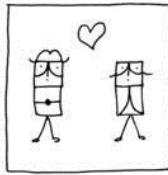
- 3 paragraphs

Handmade Responses

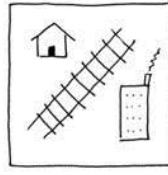
In addition to composing written responses to the reading assignments as blog posts, students may also include handmade responses that in some way illustrate the main argument or concepts depicted in the reading assignments. These illustrations must be based upon one or more of the 21 visual formats below and be included as an image in the blog post. These images may be drawn and converted via photography or scanning into an electronic image to be included in the blog post, or they may be created by hand, finger, mouse, or stylus using an electronic drawing application. Inserted images such as those available in Microsoft Office products and clip art are not allowed.

This drawing should be a combination of images, words, and colors in the white space of the page. Again, the drawing must be an original handmade drawing, follow one or more of the 21 visual formats, and include no clip art. Whichever handmade response format you select, your drawing should be effectively developed, centered, balanced, and include at least three colors (black may be one of those colors).

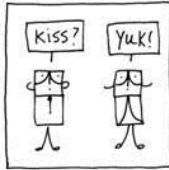
21 Visual Formats for Handmade Thinking



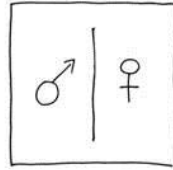

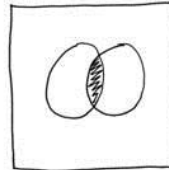

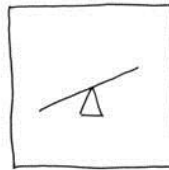

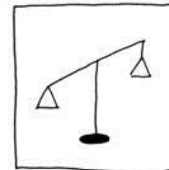

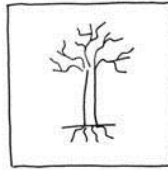

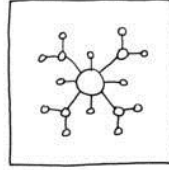

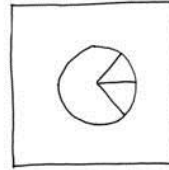

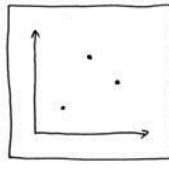

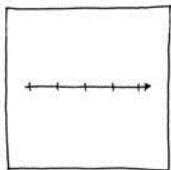

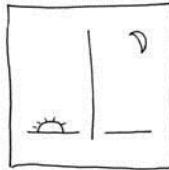

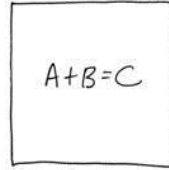

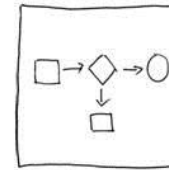

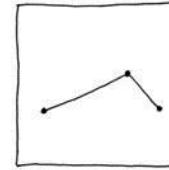
BEFORE & AFTER



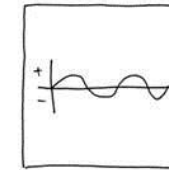

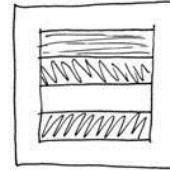
